BYLAW NO:100

A BYLAW OF WAKAW LAKE REGIONAL PARK AUTHORITY, OF THE PROVINCE OF SASKATCHEWAN, TO PERMIT THE OPERATION OF A GOLF CART ON ROADWAYS AND TRAILS WITHIN THE LIMITS OF WAKAW LAKE REGIONAL PARK.

Wakaw Lake Regional Park Authority, of the Province of Saskatchewan, enacts as follows:

- 1. With the approval of the Wakaw Lake Regional Park Authority, it shall be lawful to operate a golf cart on all designated roadways and trails within the limits of Wakaw Lake Regional Park (hereinafter called 'the Park').
- 2. No person shall operate a golf cart within the limits of the Park without a valid driver's license issued pursuant to The Traffic Safety Act.
- 3. No person shall operate a golf cart within the limits of the Park unless the owner of the golf cart has obtained written approval from the Wakaw Lake Regional Park Authority. Written approval shall consist of a seasonal registration sticker that is issued by the Park and shall be affixed, and kept affixed on the rear of the golf cart in a manner that is visible at all times.
- 4. All personal and public liability shall be the responsibility of the owner/operator of the golf cart. The owner shall be required to sign a release of liability/waiver of claims, assumption of risks and indemnity agreement in the form prescribed by the Wakaw Lake Regional Park Authority. The owner shall be required to furnish proof, whenever requested by the Wakaw Lake Regional Park Authority, that the owner and any authorized operators of the golf cart have adequate third party liability insurance coverage in respect to the operation and use of the golf cart.
- 5. The Wakaw Lake Regional Park Authority will appoint Park Officers to enforce this bylaw and the Park Officers will enforce this bylaw under authority and direction of the Wakaw Lake Regional Park Authority. All employees of the Wakaw Lake Regional Park Authority qualify as Park Officers. Any Park Officer, Peace Officer, or Police Officer may stop and inspect any golf cart within the Park to ensure that the golf cart has a valid seasonal registration sticker affixed.
- 6. Any person who contravenes any of the provisions of this bylaw, or the rules and regulations pertaining to the use of golf carts that are written within the Golf Cart Registration Application, is guilty of an offence and may have the golf cart seasonal registration canceled without notice and may be required to remove the golf cart from the Park. The Wakaw Lake Regional Park Authority may refuse to issue a golf cart seasonal registration and may refuse to allow a golf cart to enter the Park.

In this bylaw:

(i)"golf cart" means a self-propelled vehicle that Is designed primarily for the movement of people on the prepared surface of a golf course and has four smooth tread Turf Tire wheels in contact with the ground; but does not include an all terrain vehicle designed for use on unprepared surfaces, a motorcycle or motor bike, a snowmobile, an agriculture implement or special mobile machine as defined in the Traffic Safety Act, or any vehicle that is required to be registered pursuant to The Traffic Safety Act.

(ii) "the Park" is defined as those lands falling within the boundaries of the Wakaw Lake Regional Park described by the Legal Land Description: (Parcel:X) Plan 101878320 Ext0 Surface Parcel Number 161514020 as shown in the attached Information Services Corporation of Saskatchewan document.

(iii) "third party liability insurance coverage in respect to the operation and use of the golf cart" means: Motorized Vehicle Liability insurance for "bodily injury" or "property damage" to someone else arising out of an individual's ownership and the use or operation of their motorized golf cart.
